Depending on where your booth is located, electricity may be available for an additional fee. Please let us know in your application if you require electricity and exactly what equipment you will be using. Any electricity provided is single phase and only 20 amps will be provided. If this does not meet your requirements please contact the Chamber of Commerce to see if other arrangements can be made. Changes must be accomplished by March 6, 2009. No changes will be allowed after that date. **THERE WILL BE LIMITED AVAILABILITY FOR ELECTRICITY AND SPACES WILL BE ASSIGNED BY THE CHAMBER IN ACCORDANCE WITH FESTIVAL VENUE.**

BOOTH DEFINITIONS:

Arts/Crafts – Items that are high quality and hand-crafted such as wood working, quilting, weaving, painting, jewelry, papercrafts, leather goods, soaps, candles, tin crafts, fabric crafts, etc.
